



ROOSEVELT CHILDREN ACADEMY INTERNET USE AGREEMENT

Roosevelt Children Academy is committed to optimizing student learning and teaching. The School considers student access to a computer network, including the Internet, a powerful and valuable educational and research tool. It encourages the use of computers and computer-related technology in the School's classrooms to advance and promote learning and teaching.

The computer network can provide a forum for learning various software applications. Online databases, bulletin boards, and electronic mail can significantly enhance educational experiences and provide statewide, national, and global communication opportunities for staff and students.

The Regulations and handbooks developed by the School provide specific guidance and rules governing the use and security of the district's computer network. The School's computer network and equipment users shall comply with this policy and regulation. Failure to comply may result in disciplinary action, suspension, and revocation of computer access privileges.

Access to people worldwide also comes with the availability of material that may not be considered educational value in the school setting. On a global network, it is impossible to control all materials, and an industrious user may discover controversial information. We strongly believe, however, that the valuable information and interaction available on the network far outweigh the possibility that users may procure materials inconsistent with the district's educational goals.

The smooth operation of the network relies upon the proper conduct of end users, who must adhere to the following guidelines listed under Internet terms and conditions. These guidelines are provided here so that you are aware of the responsibility you are about to acquire. This requires efficient, ethical, and legal utilization of the network resources. If a Roosevelt Children Academy user violates these provisions, their account will be terminated, and future access can be denied. The signature at the end of this document is legally binding and indicates the party who signed it has read the terms and conditions carefully and understands the significance.

The Roosevelt Children Academy Charter School will require all parents/guardians, teachers, and students to execute the release-user agreement based on the guidelines listed under the following Internet terms and conditions.

Internet - Terms and Conditions:

1. Acceptable Use -

The purpose of the Internet is to support research and education in and among academic institutions by providing access to unique resources and the opportunity for collaborative work. The use of your account must support education and research and be consistent with the educational objectives of the Roosevelt Children's Academy School. Use of another organization's network or computing resources must comply with the rules appropriate for that network. The transmission of any material that violates United States or state regulations is prohibited. This includes, but is not limited to, copyrighted material, threatening or obscene material, expressions of bigotry, racism, or hate, or material produced by trade secrets. The use of commercial activities is generally not acceptable. Use of product advertisement or political lobbying is also prohibited.



2. Privileges -

The use of the Internet is a privilege, not a right, and inappropriate use will result in the cancellation of those privileges. Each student who receives an account will be responsible for that account and its usage. Therefore, your account should never be shared with anyone other than the School's Internet Coordinator. The District Internet Coordinator or Building Administrator will deem what is inappropriate use, and their decision is final. This may result in a revocation or suspension of specific user accounts.

3. Network Etiquette -

You are expected to abide by the generally accepted rules of network etiquette. These include, but are not limited to, the following:

- Be polite. Do not get abusive in your messages to others.
- Use appropriate language. Do not swear, use vulgarities, or any other inappropriate language.
- Illegal activities are strictly forbidden.
- Do not reveal your personal address or telephone number.
- Note that electronic mail (e-mail) is not guaranteed to be private. People who operate the system do have access to all mail. Messages relating to or in support of illegal activities may be reported to the authorities.
- Do not use the network in such a way that you would disrupt the use of the network by other users.
- All communication and information accessible via the network should be assumed to be the property of the Roosevelt Children's Academy Charter School.

4. Security -

Security on any computer system is a high priority, especially when the system involves many users. If you can identify a security problem on the Internet, you must notify a Roosevelt Children's Academy administrator or Internet coordinator. Do not demonstrate the problem to other users. Attempts to log onto the Internet as a system administrator will result in the cancellation of user privileges. Any user identified as a security risk or having a history of problems with other computer systems may be denied access to the Internet.

5. Vandalism -

Vandalism will result in the cancellation of privileges. Vandalism is defined as any malicious attempt to harm or destroy the data of another user, the Internet, or any of the above-listed agencies or other networks connected to the Internet. This includes, but is not limited to, the uploading or creation of computer viruses.

I understand and will abide by the above Internet Use Agreement. I know violating the abovementioned regulations is unethical and may constitute a criminal offense. Should I commit a violation, my access privileges may be revoked; School disciplinary actions may be taken, and appropriate legal action.
