SCHOOL OPERATION Budget Update: – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment and Approved Budget presentation for 2020-21. Enrollment update presented reflected a student count of 707 as of May 25th. Of that total 551 students re-registered. Incoming students registered 156. The budget is based on student count of 630.

The Approved Revised Budget for fiscal 2020-21 presented as of May 31st reflected total budgeted full year (FY) revenue is \$12.5 million. YTD recognized \$11.2 million. On target for current revenue collections. Total budgeted (FY) direct expenses \$9.8 million. Spending YTD \$9.3 million. Total budgeted (FY) indirect expense is \$2.8 million. Spending YTD \$2.4 million. On pace for spending budgeted expenses. The Approved Budget for fiscal 2020-21 presented: Enrollment budget presented 630. Budgeted full year (FY) revenue is \$12.5 million. Budgeted direct expenses \$9.8 million. Budgeted indirect expense \$2.8 million.

SCHOOL OPERATION: Facilities/Construction:

- 1) Architect is now working on Phase two: construction documents consist of Mechanical and Structural Drawings. Finalizing Nassau County Site Plans. NYS variance is not required for connecting both buildings.
- 2) Real Estate Attorney reviewing Contract for Sale and Appraisal of 170-174 Babylon Turnpike.

Other: Safety Committee May Report:

- 1) Fire Drills: All 12 fire drills were completed for 2020-21 without incident.
- 2) Bus Drills: All 3 bus drills were completed for the school year.
- 3) Lock Down Drills: There will be 2 more drills performed this month following the Covid-19 guidelines. Principals will decide what day the drill is scheduled.
- 4) Evacuation Drill: Both sites are set to perform this drill on May 27, 2021 at 9:30am at their designated evacuation location. To help expedite this process, Speed bags have been created. (A bag on wheels containing the binder of emergency contact information for all students in the given building along with a First Aid kit) There will be a point person that will handle the transport of this bag during the drills. HR will have a Speed Binder for the Staff members.
- 5) Building Concerns: Window screens in need of repairs are scheduled to be completed. Other: Health and safety continues to be a high priority. Daily building cleaning and sanitizing of high touch areas continues.

- Summer School
 - Current teacher Interest is low, especially in K-4
 - TA will need to provide instruction for grades K-4
 - 5-8 teachers may/will need to teach multiple grade levels
 - Promotion in Doubt
 - Meetings are organized and were scheduled to begin on May 19, 2021
 - It is a school-based team process.
 - o First, you should determine who is still on your list of students who you believe should be retained--your decision should include a multitude of information relating to the whole child-- grades, work ethic, performance, progress, ability, and attendance are just a few of the criteria that should be used to make your determination.
 - O Second, you will bring your list to the meetings and the committee (counselors, deans, principals, any RTI or ELL teacher who works with the students) will listen to your reasons why you have made this suggestion. It is up to you to provide the data and/or information about each student. If you are on the 6th-8th grade teams, you should all provide individual information for each subject, speaking as in agreement.
 - O Third, the committee together with the classroom teacher(s) will discuss what is in the best interest of each student on a case-by-case basis and make a determination collaboratively.

- 2021-2022 School Year Planning
