**SCHOOL OPERATION Budget Update:** – Chief Operation's/Financial Officer (COO&CFO) presented the Updated Enrollment presentation for 2023. Enrollment update presented reflected a student count of 716 as of April 16<sup>th</sup>. Ahead of last year's pace. Of that total 550 students re-registered. Incoming students registered 166 Of that total 66 were incoming Kindergarten. The budget is based on a student count of 790.

The APPROVED Budget for fiscal 2023-24 presented as of April 30<sup>th</sup> reflected 2023 Enrollment Budget 790. Total budgeted full year (FY) revenue is \$13.6 million. # Middle School Report:

### **ACADEMICS:**

- ❖ Will be conferencing with students who were classified as at risk during the first conferencing sessions. Action plans for 5<sup>th</sup> through 7<sup>th</sup> have been completed by grade level teachers. Will meet with grade level teachers upon our return from Spring break to discuss the progress of the students who an action plan was created for.
- ❖ Average daily student attendance is at or above 90%.
- ❖ Students were able to experience the Solar Eclipse. Our science teachers took time during their lessons to teach about the Solar Eclipse. The week prior to the Solar Eclipse we had another teachable moment about natural phenomena-our Earthquake. Our students were unsettled but were very calm and engaged when we discussed earthquakes and how they occur.
- ❖ We conducted another simulation during the ELA blocks to again model to our students the procedure for the CBT version of the assessment and the tools that are available to them. The simulation took place on April 9 for ELA and will take place on May 7 for math.
- ❖ The NYS ELA assessment was administered on April 10 and 11. The NYS math assessment will be administered on May 8 and 9. The NYS 5<sup>th</sup> and 8<sup>th</sup> grade science assessment will be administered on May 15. All make-ups will be administered in between these administration dates. As of to date, only 21 students opted out of taking the ELA NYS assessment. Most students who opted out were from 8<sup>th</sup> grade. It is my opinion that students are feeling more confident. Doing the assessment electronically was simpler than the paper base and was not as overwhelming for the students.
- ❖ Based upon recent assessment data, between 50% and 70% of our student population are performing at or above level three in ELA and math. Between 60% and 75% of our students are performing at level 3 or above in science and social studies. 47% of our new students are performing at level 3 or above in math and 70% in ELA. 49% of our cohort students are performing at level 3 or above in math and 64% in ELA.
- ❖ 54 students receive RTI services at the middle school.
- Cycle 2 ended on March 8.

- ❖ 6 students exited from the RTI program in grades 5, 2 students from grade 6, 1 student from grade 7, and 4 students from grade 8.
- ❖ We currently have 26 middles school students that have IEPs. 6 middle school students have 504 plans.
- ❖ Referrals were submitted for 23 students; 15 students are being evaluated currently schoolwide.
- ❖ We have had 17 suspensions since the last Board report. This is 1 more than this time last year. The suspensions were group suspensions.
- ❖ In ENL students are preparing for the NYSSLAT assessment. We currently have 39 students participating in the ENL program. This number does not include students who are at the commanding level. We have 6 students at the commanding level. The administration of the NYSESLAT is scheduled to begin on Monday, April 15.
- ❖ We currently have 3 eighth grade students participating in our work study program.

  Students assist in the admin building and in the Pantry. Participation in the program is reassessed every quarter because students are required to maintain a 90% average.
- ❖ Coaches and the Dean of Students are practicing with teachers to help develop their skills in the classroom (delivery in instruction and classroom management).
- ❖ On April 18<sup>th</sup> there will be a noon dismissal. In the afternoon from 1 pm to 4 pm we will host professional development for staff. The focus of PD will be on wellness, subject level planning, discipline, analyzing the standards, and planning for skills to be taught in preparation for the upcoming math and science assessment as well as the new school year. Teachers will also review and finalize their At-Risk Students Action Plans.
- ❖ There are 45 students in Saturday school and after school has approximately 100 to 115 students attending during the school week.
- ❖ We currently have five vacancies: 1 math teacher, 1 permanent sub., 1 ELA teacher and 2 TAs.
- ❖ We have 0 known Covid cases since the last Board meeting.

### ELA:

- ❖ 5th graders continue their module which focuses on the essential questions: "What is the role of sports in American culture?" and "How have athletes broken barriers during the historical era in which they lived?" They are proceeding with the whole class study of the biography, Promises to Keep: How Jackie Robinson Changed America by his daughter, Sharon Robinson. As they embark on the second half of the unit, they will listen to and summarize chapters, closely read excerpts, and think about the relationship between people and events in the text by continuing to determine factors for Jackie Robinson's success. Test taking strategies have also been a focus over the last few weeks.
- ❖ 6th Grade has completed the second module which focused on the Essential Question: How can the design thinking process help solve critical problems? They are progressing in the next module which focuses on Remarkable Accomplishments in Space. Across Unit 1, students read engaging informational texts about important events in the Space Race of the mid-twentieth century, leading up to the Apollo 11 moon landing. Test taking strategies have also been a focus over the last few weeks.
- ❖ 7th Grade begins the next module which focuses on the Essential Questions: What are epidemics? How do they develop? How do people respond to an epidemic? In Unit 1, students begin exploring the history of medical epidemics and focus on people's mindsets and contributions, and how they behaved differently from those around them. Students define what a medical or biological epidemic is, answering questions such as: what characteristics do the large-scale disease outbreaks that we refer to as epidemics have in common, and how do they spread? Test taking strategies have also been a focus over the last few weeks.

8th Grade continues with the current module that focuses on the Holocaust answering the essential questions: What was the Holocaust, and how did it occur? Why do we

❖ remember it? How did victims and survivors respond, and how can we honor their voices? In this module, students continue to learn about a terrible time period in history. They continue to develop their ability to determine and track themes, understand the development of characters, identify, and track the development of central ideas, and write narratives to honor the memories of those who served as upstanders during the Holocaust. Test taking strategies have also been a focus over the last few weeks.

## Math:

❖ 5th Grade is currently working on adding unlike fractions and solving word problems involving the addition of like fractions. 6th Grade is currently working on finding the area of a trapezoid and a triangle. 7th Grade is currently working on finding the probability of a simple event and its complement. 8th Grade is currently working on identifying and describing basic transformations of a Translation, Reflection, Rotations and Dilation.

#### RTI

- ❖ 78 Students receive RTI services at the elementary school & 54 students receive RTI services at the middle school.
- ❖ Cycle 2 for grade 4-8 ended on March 8<sup>th.</sup>
- ❖ Cycle 2 for grade K-3 ends on April 12<sup>th.</sup>
- ❖ Cycle 2 growth: 3 students exited RTI in grade 4, 6 students exited in grade 5, 2 students exited in grade 6, 1 student exited in grade 7, 4 students exited in grade 8.
- ❖ Cycle 2 data will be available for grades K-3 on April 19th.
- ❖ In Math we are using the Number Worlds curriculum for grade 4-8
- ❖ In Reading we are using both LLI & Achieve 3000
- ❖ The intervention curriculums we are using are researched based and have yielded great results over the past few years, with many students graduating from the RTI program altogether.

## **Diversity Lessons**

- ❖ Throughout March, students participated in diversity lessons with Mrs. McGrath and Mr. Cesar. Students learned why respecting differences is important. They were introduced to tips/strategies for respecting differences. We focused on the following key words throughout the lesson Diversity, Hate Crime, Human Rights, Individuality, Open-Minded, Prejudice.
- ❖ Before beginning the lesson, students were asked to answer the following question and share with the class, "What can you do to show respect to people who are different from you?" Students had the following answers. These answers have been saved and will be displayed for our next bulletin board:

Be nice, be kind, listen to people, share with them, treat them the same way you want to be treated, respect their race, religion and where they came from, respect their culture, try to relate to people, talk with people, offer to help if they need it, become their friend, show them that you care, involve them in activities, say kind words, compliment them, talk about your cultures with each other, start a conversation, encourage them and tell them that being different is good, make them feel welcomed and loved, help them understand things that they don't know about, celebrate their culture by doing one of their traditions with them, respect their choices, smile, support others, respect their opinions, communicate, ask questions about their culture, don't judge people who are different than you, give more love.

## **Peer Mediation**

❖ Our New and Improved Peer Mediation Team includes three 7<sup>th</sup> grade students and four 8<sup>th</sup> grade students.

Currently, our 8<sup>th</sup> graders are focusing on mediating student conflicts. Our 7<sup>th</sup> graders are working on promoting our program, teaching the younger students in grades 5 & 6 about conflict resolution, and recommending new members for the 2024-2025 school

❖ Career Day is set for Friday, May 17. Planning will begin next week. We will invite individuals with the following careers as well as brainstorm ideas for new participants/career fields: Nursing, Stylist, Photography, Communications, Electrician, Radiologist, Financial Advisor, Architect, Medical Assistant.

## **Discipline Report:**

- Oversee Climate and Culture for Mindfulness and Restorative Circles for building. Seventh and Eighth Grades are evolving. Eighth grade needs additional scaffolding on transitioning, uniform consistency, and high school readiness.
- ❖ Ensuring students are in full RCA uniform. Consequences scaffold for repeat offenders. Several students have served lunch detentions as well as Alternative Placement.
- ❖ Over 75% of our 8<sup>th</sup> grade has completed their Community Service requirements for graduation.
- ❖ Providing leadership with grade level meetings. Classroom management has been discussed this past month. TLAC is a go to for new teachers.
- ❖ I am seeking weekly feedback from Guidance Counselor to issue consequences to those students who are not following the behavior chart policy for signatures etc.
- Currently working with Kathy Lombardi, Senior Outreach Coordinator-Mobile Recovery Unit, Guidance and Counseling Services as well as Narda Carvene, from the Roosevelt Prevention Center on obtaining vaping videos to show to several of our students who have been out on suspension due to vaping.
- Obtaining information from Michael Natale, Community Affairs Office, Nassau County Police Department regarding phone apps that parents can utilize to track or block inappropriate messages on their children's phones.
