Middle School Report:

ACADEMICS:

- ❖ Conferencing with students is continuing. I have completed my conferencing with the seventh-grade students and will be meeting with the seventh-grade teachers next week. I plan to start meeting with our eighth-grade students soon. During these conferences we will be discussing their current academic progress and their future in high school.
- ❖ Average daily student attendance is at or above 92%.
- * Test prep groups have begun. Groups were designed using data from our January I-Ready Diagnostic assessment as well as teacher input. The goal of the test prep groups will be to reinforce skills to elevate our 2s to 3s, our 3s to 4s, and maintain our 4s. RTI, coaches, Dean of Students, Teachers, TAs, and I will all be assigned to a group to help our students achieve academic success on the upcoming NYS assessment.
- ❖ Based upon recent assessment data between 50% and 60% of our student population are performing at or above level three in ELA and math. Between 70% and 80% of our students are performing at level 3 or above in science and social studies. 53% of our new students are performing at level 3 or above in math and 71% in ELA. 50% of our new students are performing at level 3 or above in math and 65% in ELA.
- ❖ We had a good turn out for Parent/Teacher conferences. We had approximately 100 − 120 parents who showed up. It was a welcoming change to see our 7th and 8th grade parents because in the past 7th and 8th grade parents do not show up as much as 5th and 6th grade parents do.
- ❖ 54 students receive RTI services at the middle school.
- ❖ Cycle 2 ended on March 8. Students will be assessed again to determine growth.
- ❖ We currently have 26 middles school students that have IEPs. 6 middle school students have 504 plans.
- * Referrals were submitted for 23 students; 15 students are being evaluated currently schoolwide.
- ❖ We have had 8 suspensions since the last Board report. This is 50% less than this time last year.

In ENL students are preparing for the NYSSLAT assessment. We currently have 39

- students participating in the ENL program. This number does not include students who are at the commanding level. We have 6 students at the commanding level.
- Mrs. McGrath will be hosting diversity classes next week. The focus will be respect for all and embracing differences. She will be teaching the students the three steps/strategies 1. Be open-minded about people who are different from you by respecting their human right to individuality, to be truly who they are. 2. Embrace diversity to learn about different perspectives and ideas, enjoy new experiences and passions, and gain unexpected friendships or interests. 3. Reject prejudices by speaking out against them and thinking for yourself. Form your own opinions of others by getting to know them as individuals.
- ❖ College day will be held on March 21. We currently have three schools committed: York College, Delaware State, and Nassau Community College. We are waiting to hear back from Adelphi University. Students will spend time researching the schools prior to participating in the zoom presentations of the colleges.
- ❖ We currently have 3 eighth grade students participating in our work study program.

 Students assist in the admin building and in the Pantry. Participation in the program is reassessed every quarter because students are required to maintain a 90% average.
- ❖ Coaches and the Dean of Students are practicing with teachers to help develop their skills in the classroom (delivery in instruction and classroom management).
- ❖ On March 21st there will be a noon dismissal. In the afternoon from 1 pm to 4 pm we will host professional development for staff. The focus of PD will be on wellness, subject level planning, analyzing the standards, and reflecting on data.
- ❖ There are 45 students in Saturday school and after school has approximately 100 to 115 students attending during the school week.
- ❖ We currently have six vacancies: 1 math teacher, 1 music teacher, 1 permanent sub., and 3 TAs.
- ❖ We have 0 known Covid cases since the last Board meeting.

ELA:

In ELA, 5th grade recently embarked on the next module which focuses on the

- * essential questions: "What is the role of sports in American culture?" and "How have athletes broken barriers during the historical era in which they lived?" The heart of this module is a whole class study of the short but challenging biography Promises to Keep: How Jackie Robinson Changed America by his daughter, Sharon Robinson. In the first half of the unit, they read to determine main ideas and summarize chapters of the book. They also begin to identify different factors for Jackie Robinson's success, collecting evidence from *Promises to Keep* to support their thinking. In the second half of the unit, they listen to and summarize chapters, closely read excerpts, and think about the relationship between people and events in the text by continuing to determine factors for Jackie Robinson's success.
- ❖ 6th Grade continues their second module which focuses on the Essential Question:
 How can the design thinking process help solve critical problems? They are currently in the third and final unit of the module. In Unit 3, students write an informational essay organized using a problem-solution structure. They begin by reviewing a model, annotated using the Painted Essay® template. As they analyze the model, students, in pairs, co-construct a collaborative essay addressing the prompt "How did William use design thinking to solve a critical problem?"
- ❖ 7th Grade continues with the second module which focuses on the Essential Question:

 How does collaboration influence an artistic renaissance? The students are
 currently working on the third and final unit of the current module. Throughout the
 module, students have read poems and stories, listened to songs, and viewed visual and
 performing art from the Harlem Renaissance. Students will now curate their resources
 and share these works with their classroom in the Harlem Renaissance Museum as part
 of their performance task.

8th Grade has closed out the third and final unit of the Module which focused on The Essential Question: How does studying diverse sources about the same topic build our understanding? They have begun a new module that focuses on the Holocaust answering the essential questions: What was the Holocaust, and how did it occur? Why do we remember it? As well as, how did victims and survivors respond, and how can

* we honor their voices? In this module, students learn about a terrible time in history, remember the voices of victims, survivors, and upstanders, and at the same time, they develop their ability to determine and track themes, understand the development of characters, identify and track the development of central ideas, and write narratives to honor the memories of those who served as upstanders during the Holocaust.

Math:

In Math, 5th Grade is currently working on determining the common multiples and the least common multiple of a set of numbers. 6th Grade is currently working on describing sequences using Algebraic Expressions. 7th Grade is currently working on solving multi-step equations and inequalities. 8th Grade is currently working on graphing translations on the coordinate plane.

RTI

- ❖ 78 students receive RTI services at the elementary school & 54 students receive RTI services at the middle school.
- ❖ Cycle 2 for grade 4-8 ended on March 8th.
- ❖ Cycle 2 for grade K-3 ends on April 12th.
- ❖ The 2nd round of assessments is currently taking place for grade 4-8 and updated data will be available on March 22nd.
- ❖ Cycle 1 growth: 6 students exited RTI in grade 4, 11 students exited in grade 5, 2 students exited in grade 6, 11 students exited in grade 7, no students exited in grade 8.
- ❖ 19 students have not yet advanced to the next level in RTI however 37 students who remained in the program grew between 1 and 2 levels during cycle 1.
- ❖ In Math we are using the Number Worlds curriculum for grade 4-8
- ❖ In Reading we are using both LLI & Achieve 3000
- ❖ The intervention curriculums we are using are research based and have yielded great results over the past few years, with many students graduating from the RTI program altogether.
- ❖ The Goal of RTI has and will continue to be to close the achievement gap, when little to no success has been achieved, we will refer students to the CST Team and if student still shows minimal progress, a special education evaluation will be the next step, with the consent of the child's parent.
- * RTI Teachers meet with Grade level teachers monthly to discuss progress and share notes on students' performance.

Special Education:

- * Referrals were submitted for 23 students; 15 students are being evaluated currently schoolwide.
- ❖ Students are receiving resource room services as well as speech, counseling, physical therapy & occupational therapy.
- ❖ We are working more closely with our providers to ensure the academic and socialemotional success of our students.

We currently have 19 Elementary students with IEPs and 26 middles school students that have IEPs. 3 Elementary school students have 504 plans, and 6 middle school

ENL Report:

❖ Students have begun preparing for the NYSESLAT exam using the review books that were purchased. Using this material, the students review for each area of the test which includes listening, reading, writing and speaking. It is our hope that with this additional support, students will advance to a higher proficiency level or test out.

SEL & Guidance Counsellor Report:

Core Values Behavior Contracts –

Current number of students on Core Values Behavior Contract = 13

Previous number of students on Core Values Behavior Contract = 11

Description – Our Core Values Behavior Contract focuses on the following three core values: Respect, Trust, and Empathy. The parents of students that are placed on this program have all agreed to the contract expectations and guidelines. These students are monitored daily in the classrooms and hallways. Students get points for their behavior for each class, teachers leave comments as needed, and the parents are to sign the chart each evening. I will continue to monitor and track progress for each of these students, however the students and parents are responsible for the consistency of these charts and improvement of behavior. Any student that does not consistently abide by the contract and their behavior does not improve, are subject to consequences as per RCA's discipline policy. As needed, students will be added and removed to this program as we monitor student behavior.

Improving High Risk Attendance –

The number of students in our high at-risk attendance category has been fluctuating between 25 and 30 over the past month. Currently, we have 30 students that are considered high risk due to attendance issues. Over the past month, I have become more involved with these

students and families to strengthen relationships and communicate on a regular basis to improve their child's attendance and success in school. Communication with the parents has been going well and some parents communicate with me several times throughout the week to ask questions, get updates and ensure that their child is handing in all assigned work. I also meet with at risk students weekly to review attendance and grades and motivate them to improve in both areas.

Diversity Lessons –

All students will be participating in a diversity lesson throughout the weeks of March 11 and March 18.

Purpose/Objectives of Diversity Lesson:

- Students will learn why respecting differences is important.
- Students will learn and discuss the definitions of the following vocabulary words Diversity, hate Crime, Human Rights, Individuality, Open-Minded and Prejudice.
- Students will be introduced to three steps/strategies for respecting the differences of others 1. Be **open-minded** about people who are different from you by **respecting their human right to individuality**, to be truly who they are. 2. **Embrace diversity** to learn about different perspectives and ideas, enjoy new experiences and passions, and gain unexpected friendships or interests. 3. **Reject prejudices** by speaking out against them and thinking for yourself. Form your own opinions of others by getting to know them as individuals.
- Students will have the opportunity to apply the three steps/strategies as well as express their own individuality.
