

ACADEMIC PERFORMANCE AND INITIATIVES

- Update on implementation of test prep block. Test prep blocks are going well.
 - We are scheduled to administer the math post test on February 11
- Middle School
 - The math team and I are meeting to norm the Benchmark assessment. We hope to have everything graded by the first week o
 March.
 - Established a focus group to formulate action plans to address bucket items from the SPARK survey. Our first initiatives dealt with the lesson plan format, grade level minutes, and absentee packets.
 - We are still formalizing a draft for the Truancy policies, but discussions have started
 - 34 students exited from RTI. The RTI department will continue to progress monitor the students to ensure that they continue
 to perform within 1 year of their current grade level.
 - About 9 students were referred to and are receiving services from RTI. This was due to monthly meetings between teachers and RTI staff.
 - 24 All but four students have completed the IReady benchmark. 23% of students in math performed at or above grade level. 27% of students in ELA performed at or above grade level. Overall, there was a 6% increase on both the Math and ELA IReady Diagnostic assessments.
 - 25 Teachers are meeting as a grade level to draft the At-Risk letters. Letters will be mailed home by Wednesday, February 12.
 - 26 ELA, Math, and RTI staff participated in an IReady work shop on February 6th. This workshop was geared towards looking at t data and devising instructional strategies to meet the needs of the students.


ES Suspensions By Month







PARENT REPORT:

The parent group remains committed to parent focused initiatives, working in harmony with our school calendar and various school activities to help our principals and educators maintain and support an enriching learning environment for our students and healthy partnership with our families.
