 - o The plan is to continue test prep sessions beyond the NYS assessment to continue to strengthen our students academically. The purpose is to continue to close the achievement gap.


Middle School

ELA Academic At Risk Plan of Action

Teachers will utilize i-ready by using its data to assess skills and incorporate these skills into daily lessons to increase students' success.

Teachers will closely monitor students' progress and intervene by pulling small groups to provide targeted support when students are struggling and failing i-rec lessons.

Teachers and coaches will use i-ready and Data Mate benchmarking to identify the skills where students are performing the weakest and design interventions and incorporate skills into daily lessons and Do Now activities.

The coach will meet with individual teachers on an ongoing basis to create and administer quizzes to reassess these skills every two weeks to determine either move forward or reteach.

. The coach will meet with teachers to conduct standard dives and work studies to analyze student work to find common misconceptions to drive and improve instruction.

The coach will assess the effectiveness of current test prep instruction.

This what we have been doing this year for test prep to drive progress and improve student outcomes:

Prior to the start of the current year's test prep sessions, the coach grouped students according to their performance on diagnostic tests and NYS ELA standards-based assessments, allowing students to be instructed at a pace suited to their needs.

Students receive instruction biweekly in these groups using the DataMate Computer Based Testing Curriculum, which embeds NYS test questions into its lessons. This is to increase mastery of the academic material as well as to teach students how to effectively take the test on a computer and become confiden and comfortable with computer based testing.

PARENT GROUP:

The Parent Group commented: That RCA students and families participated, through a partnership with Tickets for Kids, in a Theatre outing to see "Smoke & Mirrors" at Baruch College Performing Arts Center on Saturday, March 1. The feedback from parents was complimentary of the performance and they found it a rewarding experience for the students.

CUNY-Creative Arts Team (CAT) performed at the Youth Theatre event on Saturday. CAT provides a safe nurturing space during out-of-school time, where students can have an opportunity to explore their passions, through theatre, while connecting with and learning from caring adults.

The Parent Group commented: On the schools focus on students' learning and their health and wellness. Highlighting how RCA young leaders balance their academic requirements and earn their choice to participate in various activities such as soccer, tennis, flag football or basketball teams offered by the school.

It was noted, during soccer practice this month, that the students were developing several techniques, including teamwork, discipline, physical fitness and perseverance. The soccer coach was observed repeatedly emphasizing "schoolwork first, soccer second". In addition, throughout the exercise the coach restated the steps for the drill, with the students focus on their individual drill. This level of coaching and student focus reinforces students' confidence as they practiced and displayed, they were acquiring the technique for each drill. Most importantly, it was observed how motivated and confident the young leaders were by their increased focus and confidence.

RCA has been notified of the school's approval for the upcoming NYS Public School Athletic Association Friend & Neighbor Application membership, to be a Friend and Neighbor School with Section VIII. This grants RCA the ability to compete, for the applicable grade, against Section VIII Schools in the surrounding area, in this League.
