#### ROOSEVELT CHILDREN'S ACADEMY CHARTER SCHOOL

**MOTION TO OPEN MEETING:** Chair Rev Reginald Tuggle officially called the meeting to order at 6:07 P.M. A motion was made by DWashington to open the Board Meeting. The motion was seconded by Burden.

**INTRODUCTORY COMMENTS:** The Chair opened the meeting with a welcome to everyone and thanked everyone for their participation on behalf of the entire board. The Chair further commented on how quickly we arrived at the end of the year 2024 while addressing many challenges during this year and preparing for the holidays. Further wishing everyone a healthy and happy holiday season. The CEOA commented on the staff holiday event and thanked Trustee Vanderburg for his generosity in hosting todays event for the 6<sup>th</sup> grade class winners, after which the CEOA presented data from the initial rendering of Open Architect Software Platform approved by the board. The CEOA noted, while in the developmental stage, the process of working with the vendor to capture and customize additional data feeds to refine the information reporting continues. The software platform is used to integrate multiple assessments of data sources into a unified dashboard (i.e. attendance, state assessment visualizer system, benchmarking exams systems etc). This tool enables principals, teachers, and instructional leaders to visualize assessment data feeds and other data feeds, view progress, understand any changes in the data that may require timely action, and to address appropriate actions to continue the progress as presented to the board. The Chair commented on the usefulness and comprehensiveness of data and asked about how the staff will be trained to use the system. The CEAO elaborated on the plan for the scheduled training to use and report the data.


#### SCHOOL EXECUTIVE REPORT

I. Roosevelt Children's Academy Elementary School Attendance




II. Roosevelt Children's Academy Middle School Attendance


## III. RCA Grades 3-8 State Test Visualizer:






